IN ORDER TO KEEP OUR REAL ESTATE AND PERSONAL PROPERTY RECORDS UP TO DATE WITH YOUR MOST RECENT IMPROVEMENTS, PURCHASES AND DELETIONS, <u>YOU MUST</u> FILE A FORM 762 REPORT OF ALL EQUIPMENT, VEHICLES, OWNED OR LEASED LOCATED IN BUCHANAN COUNTY AS 1/01/2024. THE DUE DATE IS MAY 01, 2024 FOR THIS INFORMATION.

- (1) FOR EACH WELL WITH A COMPRESSOR OR PUMPING STATION (INCLUDE 911 ADDRESS) AND EQUIPMENT, NUMBER OF COMPRESSORS, PIPELINE, METERS, TRANSFORMERS \*ETC, THAT MAKES UP THE STATION, NAME OR IDENTIFYING NUMBER AND LOCATION. WE NEED THOSE ITEMS THAT MAKE UP THE STATION LISTED AS TO DATE PURCHASED AND ORGINIAL COST.
- (2) TOTAL PURCHASE COST AND INSTALLATION COST OF GLYCOL UNITS, PIPELINE, CASINGS, PUMPING UNITS, COMPRESSORS, LIQUID LEVEL INDICATORS, MAINS, METERS, GATHERING LINES, UTILITY POLES, ELECTRIC POWER LINES AND TRANSFORMERS ETC... THAT IS NOT A PART OF THE COMPRESSOR OR PUMPING STATION.
- (3) LIST OF LEASED EQUIPMENT, TYPE, ORIGINAL COST, AND DATE ACQUIRED, WITH THE NAME AND ADDRESS OF THE LESSOR (FORM 762L)
- (4) A LIST OF EACH BUILDING OR SHED, YEAR BUILT, TYPE OF CONSTRUCTION, ORIGINAL COST, SIZE AND 911 ADDRESSES.

FAILURE TO COMPLY WILL RESULT IN A STATUTORY ASSESSMENT BASED ON VIRGINIA CODE SECTION 58.1-3519.
