INSTRUCTIONS for BUCHANAN COUNTY RETURN OF TANGIBLE PERSONAL PROPERTY – LEASING COMPANIES ONLY

- Section 58.1-3518 of the Code of Virginia requires that ALL tangible property *owned*, *leased*, *rented*, *or borrowed* as of January 1 of any year, which was used or available for use in a business/profession and which was located in Buchanan County must be filed on a personal property return.
