IN RE: CONSIDER ADOPTING A RESOLUTION IN OPPOSITION TO ANY FURTHER RATE INCREASES REQUESTED BY APPALACHIAN POWER COMPANY

Craig Stiltner, Rocklick District Supervisor stated I requested this resolution be drafted for the board to consider. Even after the most recent snow fall of several inches around the county, I've received more telephone calls about Appalachian Power Company's (AEP) rate increase than issues with the snow, he stated.

People are already trying to decide how to pay their medical expenses along with the increase in food and now they're worrying about paying their power bills, stated Mr. Stiltner.

The CEO of AEP makes over \$1.5 million each year without including bonuses and other compensation, stated Mr. Stiltner. Board members for AEP makes over \$300.000 each year. I'm not going to stop until something is done with these rate increases. In other surrounding counties, AEP is cheaper than it is here, he stated.

What's the reason behind this. The State Corporation Commission (SCC) approves the rate increase for AEP, which is uncalled for and unjustified, voiced Mr. Stiltner.

After a general discussion by the board upon motion by Trey Adkins seconded by Craig Stiltner and with a roll call vote of seven (7) yeas, Lee Dotson, G. Roger Rife, David Rose, Trey Adkins, Craig Stiltner, Tim Hess, Jeff Cooper and zero (0) nays, this board did hereby adopt the following Resolution in opposition to any further rate increases requested by Appalachian Power Company:

RESOLUTION IN RE: STATEMENT OF OPPOSITION TO APPALACHIAN POWER COMPANY'S RATE INCREASES

WHEREAS, Appalachian Power Company continues in requesting for rate increases for electric bills of their residential customers in Buchanan County, Virginia; and

WHEREAS, many of the citizens of Buchanan County, Virginia are dependent upon a fixed income and virtually all citizens of Buchanan County are struggling to cope with increased food, medicine, fuel and utility costs due to inflation; and

WHEREAS, the State Corporation Commission found as recently as this past November 2023 that Appalachian Power Company was seeking an excessive base rate increase of \$25.03 per 1,000 kilowatt-hours but still permitted an increase of \$16.03 per 1,000 kilowatt-hours for residential customers; the new rates will take effect 60 days from the date of the order, which would be Jan. 29, 2024. The development follows a recent SCC report that said an average Appalachian customer's monthly bill rose by about \$35 just between July 2022 and July 2023; The SCC's approval allows Appalachian to, among other things, increase its annual revenue by \$127.3 million; pursue a return on equity of 9.5%, up from its current state-authorized ROE of 9.2%;

WHEREAS, Appalachian Power Company had previously received approval of a fuel factor rate increase from the SCC on February 10, 2023 that increased the average residential customer's monthly bill by \$3.00; this increase was on top of two other increases from last year resulting in an \$11 increase to the average monthly bill for transmission costs and \$2.37 a month to pay for costs generated by requirements of the Clean Economy Act; and

WHEREAS, when all of the approved APPCo increases in rates approved by the SCC in 2023 are totaled together, residents in Buchanan County are facing an increase in the average power bill of at least \$51 per month since July 2022; and

WHEREAS, it is unfair to constantly shift costs increases from a multi-billion-dollar corporation with a guaranteed rate of return on equity of 9.50% to its customers, many on fixed incomes who are already struggling with sky rocketing costs caused by inflation; and

NOW THEREFORE, BE IT RESOLVED, by the Buchanan County Board of Supervisors to state its opposition to any further rate increases requested by Appalachian Power Company without some type of reduction in Appalachian Power Company's rate of return on equity so prevent an unfair shifting of costs from Appalachian Power Company to its residential customers.

FURTHERMORE, BE IT RESOLVED THAT the County Administrator is directed to send an appropriate cover letter along with this resolution to the following: Governor Glenn Youngkin, the State Corporation Commission, Appalachian Power Company, U.S. Congressman Morgan Griffith, State Senator Travis Hackworth, State Senator Todd Pillion and to State Delegate William Morefield and Appalachian Power Executives.

- L. Lee Moise, County Attorney stated a emergency ordinance was adopted by the board on January 8th, 2024, which included accepting male and female coyotes for bounty payments. The payment for a coyote claim when from \$50.00 to \$100.00 for both male and female claims. Also, the emergency ordinance was adopted for a six (6) month period, which would end on July 8th, 2024, he stated.

While preparing the amended ordinance for the agenda today, there were a couple of issues that needed to be addressed, stated Mr. Moise. The first one is clarifying that the claimant must kill the coyotes within Buchanan County and secondly, that the claimant must be a resident of Buchanan County, he stated.

Also, there is the question of whether the coyote carcasses can be turned in at the Buchanan County Transfer Station and the County Garage, asked Mr. Moise?

Several said both the transfer station and county garage can receive the carcasses.

Craig Stiltner, Rocklick District Supervisor stated there's 3,000 acres of IDA property on Southern Gap where coyotes are migrating with the Elk. We need to send a letter to the IDA asking them to request the Virginia Department of Game and Inland Fisheries (VDGIF) and Leon Boyd on the VDGIF Board to allow coyotes to be trapped on the IDA property.

COUNTY CODE"

After a general discussion by the board upon motion by Trey Adkins seconded by Craig Stiltner with a roll call vote of seven (7) yeas, Lee Dotson, G. Roger Rife, David Rose, Trey Adkins, Craig Stiltner, Tim Hess, Jeff Cooper and zero (0) nays, this board did hereby adopt an Amended Ordinance entitled: "An Ordinance to Establish Payment of a Bounty for Coyotes in Accordance with Section 15.2-926.1 of the Code of Virginia (1950). Specifically, the proposed amendment to Chapter 22, Animals, Article III, Bounty for Coyotes of the Buchanan County Code."

CHAPTER 22, ANIMALS ARTICLE III, BOUNTY FOR COYOTES

"AN AMENDED ORDINANCE TO ESTABLISH PAYMENT OF A BOUNTY FOR COYOTES IN ACCORDANCE WITH SECTION 15.2-926.1 OF THE CODE OF VIRGINIA (1950), AS AMENDED."

Section - <u>Killing of Coyotes Permitted: Bounty Established: Procedures for Claims:</u>

- A. The killing of both female and male coyotes within the boundaries of Buchanan County, Virginia, is hereby authorized for bounties upon the following conditions: Upon proper proof that the claimant presenting the coyote carcass must verify that said claimant is a resident of Buchanan County, Virginia and that the coyote was killed upon land located within the boundaries of Buchanan County, Virginia, all such information verified under oath. The claimant shall supply the 911 address of his or her residence in Buchanan County and the 911 address of the location of where in Buchanan County the coyote was killed. A bounty of One-Hundred Dollars (\$100.00) shall be paid by the County from available funds, for each female and male coyote killed within the boundaries of the County. The entire coyote carcass shall be presented at the County Sanitary Landfill or County Garage to County's designated agent before payment of the bounty.
- **B.** All bounty payment(s) shall be contingent upon the furnishing of such identifying information as requested by the County's designated agent and the Board of Supervisors shall be the approving authority for payment of all claims presented.

Section - Available Funds Not to Exceed \$5,000.00:

The total dollar amount of bounties to be paid under this ordinance shall not exceed the sum of Five Thousand Dollars (\$5,000.00) per fiscal year (July 1^{st} to June 30^{th}), except by additional appropriation by the Board.

Section - Unlawful Acts; Penalties:

It shall be unlawful for any person to present a false claim or to receive any money on a false claim under this ordinance which act shall constitute a Class One Misdemeanor, punishable by a fine not to exceed \$2,500.00 and/or confinement in jail for a period not to exceed one year.

- C. This Emergency Ordinance was adopted by the board of supervisors on January 8th, 2024,
- **D.** This Ordinance is adopted pursuant to the authority vested in the Board of Supervisors by Sections 15.2-1425, 15.2-1426, 15.2-1427 and 15.2-926.1 Code of Virginia, 1950, as amended.
- **E.** This Ordinance repeals any Ordinance of Buchanan County which is in conflict with the provisions hereof but only to the extent that such Ordinance is in conflict herewith.
- **F.** This amended ordinance shall remain in effect for six months from January 8, 2024, at which time the amount of the bounty shall return to \$50.00 only for each female coyote killed within the boundaries of Buchanan County by a resident of Buchanan County.

Pike County, Kentucky has only three clerks, which is the same as supervisors, stated Mr. Adkins.


