After a general discussion by the board upon motion by Craig Stiltner seconded by Trey Adkins and with a roll call vote of seven (7) yeas, Craig Stiltner, Trey Adkins, Jeff Cooper, Tim Hess, David Rose, Lee Dotson, G. IN RE: SHERRY FLETCHER, SUPERINTENDENT AND CURTIS ELSWICK WITH SKANSKA USA BUILDING, INC. – REQUEST SUPPORT FOR THE CONSTRUCTION OF TWO ROUNDABOUT INTERSECTIONS, WHICH WILL INCLUDE THE COMPLETION OF THE CONNECTION OF RUFFED GROUSE DRIVE AT AN ESTIMATED COST OF \$800,000.00

Sherry Fletcher, Superintendent and Curtis Elswick, Project Manager with Skanska USA Building, Inc. requested support for the construction of two (2) roundabout intersections, which will include the completion of the connection of Ruffed Grouse Drive at an estimated cost of \$800,000.00.

Mr. Elswick requested the board to consider a commitment in the amount of \$800,000 in the upcoming Coal Haul Road budget. The \$800,000 will assist with the cost of sidewalks, two (2) roundabouts and will connect the school to the subdivision. This will be on the easternmost side of the school, he commented.

This road would be a county road and the county would have use of the road, although it would be dedicated for the use of the school, stated Mr. Elswick.

Trey Adkins, Knox District Supervisor stated let me get this straight, the school system put bids out for a school worth \$75 million and you have \$82 million out of Hurley High School and \$9 million out of the vocational school, which makes \$91 million and you received \$27 million from the state that can only be used for the new construction on the school. So the school has around \$119 million. Is that correct, asked Mr. Adkins?

Yes, stated Mr. Elswick.

So you have \$119 million or so to build a \$75 million dollar school, but I've been told that the price of the new school was up to \$119 million, stated Mr. Adkins. How did you not go back out based upon procurement, a bid or an RFP on the new school?

The cost keeps going up not only for the design, but for the construction, stated Mr. Elswick. We're trying to get the best school for the county and all the amenities that we can get, he commented. If we can get a commitment for the \$800,000 for the road, then funding can go to something else, he stated.

My vote will be not to give the additional \$800,000 for the new road, stated Mr. Adkins. I advise to you is to spend your money wisely. Also, it would be a disgrace if this board would give you another \$800,000, he stated.

Craig Stiltner, Rocklick District Supervisor asked Mr. Elswick when the new school could've been started, it if hadn't been held up for so long, could it have saved money?

Yes, stated Mr. Elswick. We could've started the new school around two (2) years

ago and it would've saved an estimated \$10 million in cost.

Mr. Stiltner, stated this project has been delayed four (4) to five (5) years and the cost has went up over 5% each year for the new school. The delay has increased the new school over \$20 million. I'll vote for this it's not our fault, he commented.

If we had built the school on time in the very beginning, they wouldn't be here asking for an additional \$800,000, stated Mr. Stiltner.

G. Roger Rife, Chairman stated we keep increasing our budget after we set one. Last year, we increased the budget by \$53 million and it keeps going up, he stated. If something goes wrong, we are going to be in trouble. What happens when you don't have the money and you still have to pay, he stated.

Jeff Cooper, Garden District Supervisor stated it give me heartburn about the process throughout the entire school consolidation, we were not considered. Some of us, let everyone know we were not in support of the consolidation process. The school system let us know, we don't have much of a choice. They made the decision, we don't need you, he stated. When you all falls a little short of money, who do you come to?

Mr. Stiltner stated \$24 million was wasted because of all the hold-ups. Also, \$3 million per year will be saved, due to consolidation and no one loses their job.

Before long, the Buchanan County Public Service Authority will be needing additional funding for the sewer treatment plant and their new PSA Office on Southern Gap, stated Mr. Adkins.

After a general discussion by the board upon motion by Craig Stiltner with no second to his motion and with a roll call vote of three (3) yeas and four (4) nays, the motion failed to support additional funding from the Coal Haul Road budget in the amount of \$800,000 to Buchanan County Public Schools

Trey Adkins, Knox District Supervisor stated the Virginia Department of Transportation (VDOT) invoices include two (2) invoices regarding the Hurley Elementary/Middle School project.

Erica Miller, Residency Administrator for VDOT stated yes, VDOT has spent \$37,000 to date on the project.

They may have done \$4 to \$5 thousand on the project, stated Mr. Adkins. I would like to see the invoice. I put \$135,000 on the project, he commented.

There's funding there for the project, stated Ms. Miller.

There's a lot of overlay projects in other districts in the county, stated Mr. Adkins. Nothing has been done in the Knox District, he commented. Please do not pay the invoices for Knox Magisterial District regarding the Hurley Elementary/Middle School project, stated Mr. Adkins.

After a general discussion by the board upon motion by Trey Adkins seconded by Lee Dotson and with a roll call vote of seven (7) yeas, Craig Stiltner, Trey Adkins, Jeff Cooper, Tim Hess, David Rose, Lee Dotson, G. IN RE: GENERAL DISCUSSION

Jeff Cooper, Garden District Supervisor stated I noticed that a bridge was washed out in Washington County, Virginia and it was replaced within a week. I've asked several times for the bridge at Big Branch Road, route 715 that was washed out in the 2022 flood to be replaced.

Eric Miller, Residency Administrator stated May 5, 2023 a letter was sent to Mr. Horn, County Administrator regarding a temporary bridge for Big Branch Road, route 715 from the Department of Transportation. There were several factors making it impossible to install a temporary bridge at the location.

The previous bridge was 86 feet long and now the span is greater than 100 feet. Therefore, a temporary bridge is 90 feet long and will not span this stream without building an abutment or pier in the floodway, stated Ms. Miller. Threat of Big Sandy Crawfish in the Dismal River and the reduced limited area between the channel and the existing railroad structures are other reason, she commented.

VDOT will work to get a new bridge started at the end of October, which will be finished May 2025, stated Ms. Miller.

David Rose, Prater District Supervisor requested VDOT to remove the limbs from trees hanging along State Route 605.

I'll check with the VDOT's Roadside Division in Bristol to find a solution for the issues along the roadway, stated Ms. Miller.

Mr. Rife stated at one time we had to have three (3) dwellings with three (3) individual property owners. Later it was changed, he stated. It went to one (1) property owner to three (3) properties. This makes trailer parks available to be county roads, he voiced.

There are over 750 roads in the county road system, stated Mr. Rife.

Mr. Hess stated he would leave Johnson Road in the county road system. If the road is blocked, the county will not work it.

Dr. Carl Hackney, resident requested the board to leave county road 3059 Day Lily Road located in the North Grundy District in the county road system. I've lived there for 16 years and school buses uses one part of the road to turn in and the county has never worked the road, I work it myself, he stated.

After a general discussion by the board upon motion Trey Adkins seconded Lee Dotson and a roll call vote of six (6) yeas, Trey Adkins, G. Roger Rife, Tim Hess, David Rose, Lee Dotson, Craig Stiltner and one (1) nay, this board did hereby adopt the following Amended Ordinance regarding the proposed amendment to the Ordinance entitled: "Chapter 22, Animals, Article III, Bounty for Coyotes" regarding the increase in coyotes claims from \$50 per claim to \$100 per claim, which will include male and female coyote claims for six (6) months.

CHAPTER 22, ANIMALS ARTICLE III, BOUNTY FOR COYOTES

"AN AMENDED ORDINANCE TO ESTABLISH PAYMENT OF A BOUNTY FOR COYOTES IN ACCORDANCE WITH SECTION 15.2-926.1 OF THE CODE OF VIRGINIA (1950), AS AMENDED."

Section - Killing of Coyotes Permitted: Bounty Established: Procedures for Claims:

A. The killing of both female and male coyotes within the boundaries of Buchanan County, Virginia, is hereby authorized for bounties upon the following conditions: Upon proper proof that the claimant presenting the coyote carcass must verify that said claimant is a resident of Buchanan County, Virginia and that the coyote was killed upon land located within the boundaries of Buchanan County, Virginia, all such information verified under oath. The claimant shall supply the 911 address of his or her residence in Buchanan County and the 911 address of the location of where in Buchanan County the coyote was killed. A bounty of OneHundred Dollars (\$100.00) shall be paid by the County from available funds, for each female and male coyote killed within the boundaries of the County. The entire coyote carcass shall be presented at the County Sanitary Landfill or County Garage to County's designated agent before payment of the bounty.

B. All bounty payment(s) shall be contingent upon the furnishing of such identifying information as requested by the County's designated agent and the Board of Supervisors shall be the approving authority for payment of all claims presented.

Section - <u>Available Funds Not to Exceed \$5,000.00:</u>

The total dollar amount of bounties to be paid under this ordinance shall not exceed the sum of Five Thousand Dollars (\$5,000.00) per fiscal year (July 1st to June 30th), except by additional appropriation by the Board.

Section - <u>Unlawful Acts; Penalties:</u>

It shall be unlawful for any person to present a false claim or to receive any money on a false claim under this ordinance which act shall constitute a Class One Misdemeanor, punishable by a fine not to exceed \$2,500.00 and/or confinement in jail for a period not to exceed one year.

- C. This Emergency Ordinance was adopted by the board of supervisors on September 9th, 2024,
- **D.** This Ordinance is adopted pursuant to the authority vested in the Board of Supervisors by Sections 15.2-1425, 15.2-1426, 15.2-1427 and 15.2-926.1 Code of Virginia, 1950, as amended.

Roger Rife, Craig Stiltner, David Rose, Jeff Cooper, Trey Adkins and zero (0) nays, this board did hereby adopt the following Amended Resolution regarding the procedure for abatement of public nuisance structures.

AMENDED RESOLUTION

IN RE: PROCEDURE FOR ABATEMENT OF PUBLIC NUISANCE STRUCTURES

WHEREAS, in an effort to clean up Buchanan County of public nuisance structures, the following procedure has been proposed:

- 1) When a District Supervisor believes there is a public nuisance structure in his magisterial district that needs to be abated, he shall provide the location of same to the litter control officer;
- 2) The litter control officer shall create a file with photos of the structure and ownership documentation obtained from the Commissioner of Revenue Office;
- 3) The litter control officer shall deliver the file to the Building Code Official;
- 4) The Building Code Official shall evaluate the structure on the basis of a form provided by the County Attorney. If the Building Code Official determines the structure is a public nuisance structure that constitutes a public nuisance structure that constitutes an immediate and imminent threat to life or property, the Building Code Official shall deliver the file to Sandy Stiltner at the County Administrator's Office; If the Building Code Official determines the structure does not meet the criteria of a public nuisance structure, he shall so advise the District Supervisor;
- 5) If the file is delivered to the County Administrator's Office, Sandy Stiltner shall do a draft right of entry document for the review and approval of the County Attorney; once the right of entry document is approved by the County Attorney, Sandy Stiltner will contact the owner or owners about signing the right of entry document and shall maintain an excel document with property owner's name,

address, start date, photo's, public nuisance, right of entry, county administrator and county attorney.

- 6) The County Attorney shall review the title, check for out conveyances, liens such as deeds of trust, mortgages, judgment liens and financing statements. If the County Attorney finds liens against the property, the County will follow the ordinance and make a good faith effort to obtain the consent of the lien creditors to abate the structure; however, the inability to locate all property owners and/or lien creditors shall not prevent the County from abating a public nuisance structure that constitutes an immediate and imminent threat to life or property pursuant to Va. Code section 15.2-900 and the County's ordinance, 77-13;
- A completed checklist prepared by the County Attorney shall be reviewed and signed by the County Administrator, County Attorney and Building Code Official;
- 8) The County Administrator will determine whether to use the public works department or a third-party contractor to abate the public nuisance structure;
- 9) If a third-party contractor is used to abate a public nuisance structure, the Board of Supervisors authorizes the County Administrator to accomplish the procurement and approve the contract and execute the contract with the third-party contractor;
- 10) Regardless of whether the public nuisance structure is abated by public works or by a third-party contractor, a demolition permit shall be obtained from the Building Code Official's Office;
- 11) As part of issuing a demolition permit, the Building Code Official will determine if an asbestos study is required prior to demolition; such an asbestos study shall be required if the public nuisance structure is a commercial structure built before 1985 or a residential structure built before 1985 <u>and</u> that has more than four sleeping units (bedrooms).
- 12) It is the goal of this program to abate two to four public nuisance structures each month; and

NOW THEREFORE BE IT RESOLVED, that the Buchanan County Board of Supervisors hereby approves the proposed amended procedure of the abatement of public nuisance structures in Buchanan County; and that the County Administrator and County Attorney are authorized to take all actions necessary to effectuate the terms of this resolution.
