BID SUBMISSION

Sealed bids will be received at the Buchanan County Office of the County Administrator on the third floor of the Buchanan County Government Center Building located at 4447 Slate Creek Road, Grundy, Virginia 24614 until 10:00 AM on Monday, February 9, 2026. Bids not received by 10:00 AM on Monday, February 9, 2026 will not be considered.

SCOPE OF SERVICES

Spray two coats of Sherwin Williams black Dry fall to all surfaces above the brick line in the gymnasium and above the stage. Apply 2 finish coats of Sherwin Williams Loxon to the CMU block on the walls of the stages left and right, that had previously been painted white and orange. Prep, spot prime with DTM primer and apply 2 finish coats of DTM paint to handrail and ladder stage left. Contractor needs to supply 5 gal of DTM paint.

Recommended Sherwin Williams Products:

*Interior finishes: SW Pro Industrial water born acrylic dry fall flat black for Metal ceiling

*Brick finish: Quick dry stain block primer, finish coat of Promar 200 zero voc interior paint

*Hand rails: Apply finish coat of Pro Industrial water based semigloss paint
