The Buchanan County, Va., Board of Supervisors is requesting sealed bids for interior painting.

BID SUBMISSION

Sealed bids will be received at the Buchanan County Office of the County Administrator on the third floor of the Buchanan County Government Center Building located at 4447 Slate Creek Road, Grundy, Virginia 24614 until 10:00 AM on Monday, February 9, 2026. Bids not received by 10:00 AM on Monday, February 9, 2026 will not be considered.

BIDS MUST BE RECEIVED ON OR BEFORE 10:00 AM ON MONDAY, FEBRUARY 9TH TO BE CONSIDERED REGARDLESS OF THE METHOD OF DELIVERY UTILIZED.**

SCOPE OF SERVICES

To supply and install a 2.0-ton mini-split heat pump system, and an ERV system.

Supply and install Carrier (37MGARQ24DA3), or comparable, multi-port heat outdoor unit, with 1-(45MAHAQ18XA3) highwall indoor unit, for each shower stall.

Supply and install a Carrier (ERVXXLHB1210), or comparable, ERV system.

Supply and run 6" metal pipe supply and exhaust vents to each shower.

Supply and run 8" metal piping to the outside wall for the fresh air, and the exhaust

Supply and run all electrical circuits in EMT conduit.

Price must include Equipment, Materials, Labor, and Lift if necessary.

Warranty: One-year parts and labor, Five-year compressor.

STATEMENT OF REQUISITE QUALIFICATIONS OF BIDDERS

The successful bidder shall be properly qualified to do business in the Commonwealth of Virginia. Vendor must be licensed to do work in the Commonwealth of Virginia and have a Class B contractor's license.

The Buchanan County, Va. Board of Supervisors will not be responsible for the costs incurred by a prospective bidder in submitting a bid in this matter. The Buchanan County Board of Supervisors reserves the right to reject all bids if it is deemed in the best interests of the County.
