SCOPE OF SERVICES

A **MANDATORY** pre-bid conference will be held on **Monday, June 26th** **@ 10:00 a.m** at VEC located at 1028 Sykes Blvd., Vansant, VA 24656. Only those attending the **MANDATORY** pre-bid conference will be eligible to submit a bid.

To remove and dispose of the existing units and to supply and install the following .

- One (1) new Carrier (27SCA524A003) 2.0-Ton 15 seer Heat Pump 208/230 IPH, with R454B refrigerant
 - One (1) new Carrier (FJ5ANXB24LOO) 2.0-Ton Air Handler 208/230V IPH with 208/230v IPH IOKW Heat Kit
 - One (1) new Carrier (27SCA536A006) 3.0-Ton 15 seer Heat Pump 3PH 460V, with R454B refrigerant
 - One (1) new Carrier (FJ5ANXB36LOO) 3.0-Ton Air Handler 208/230V IPH, with 3PH 10 KW 480V Heat Kit
 - Five (5) Carrier (27SCA548A006) 4.0-Ton 15 seer Heat Pump 3PH 460V, with R454B refrigerant
 - Five (5) Carrier (FJ5ANXC48LOO) 4.0-Ton Air Handler 208/230V IPH, with 3PH IOKW 480V Heat Kit

- Comparable units may be used but proper documentation supporting comparability must be submitted along with the IFB.
- All refrigerant line sets to be replaced from air handler to outdoor unit.
 - All line sets must be verified for size and length
 - All liquid lines will require a liquid line solenoid full size of unit connection

- All line sets to be properly supported inside and outside
- All line sets to be covered on exterior walls and painted to match down spouts
- All suction lines to be insulated air tight with no gaps
- All thermostat wire to be changed from air handler to outdoor unit
- All thermostat wire to be in seal tight where exposed on the exterior of building
- All air handlers to have new drain pans with safety switches
- All system to be controlled with a Honeywell 8000 WiFi programmable thermostat
- All return grills to be changed to filter grills sized according to required system CFM

Price will include Equipment, Labor and Rigging Warranty. And also, electric heater components for each unit sized accordingly. One-year parts and labor, Five-year compressor.

All work must comply with all State and Local building codes. This is to be a “turn-key” job the price will include materials, labor and any miscellaneous materials and equipment needed to complete the job.

Work shall be completed within 45 business days, after signing of contract.

Work to be coordinated with building occupants.

Any required Permits for this project will be at the cost to the Contractor.

The successful bidder shall NOT utilize any subcontractor.

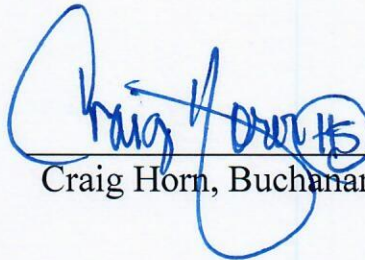
